I will remain in my seat at all times, and be respectf others keeping my hands and feet to myself. I understand that there will be no "rough hous allowed. Arguing and fighting will not be tolerated. I will respect the classroom/ school and its cleanliness; I will clean up after myself and report any disrespectful behavior to the Aftercare staff. I will avoid any verbal or non- verbal communication that shows disrespect, such as: ey rolling, talking back, yelling, and saying "I can't and I won't" when asked to do something. Payments

- \$ \$10.00 per day
- ❖ We prefer that all payments are anticipated, so that you pay for the days you will use ahead of time.
- All payments will be due on the 1st and 15th of each month. If the 1st or 15th falls on a Saturday or Sunday payments are due on the Friday before the 1st or 15th.
- ❖ A **25% late fee** will be added to any payments made <u>AFTER</u> the 15th of each month as a late charge.
- A Payments must be made in a timely manner or students will not be able to attend aftercare until paid in full.

Late Policy & Procedure

- All efforts should be made by the parents/guardians to communicate a late pick up. Please call the school office, during office hours, at 520-459-4113 or email zhorton@bereanschs.education.
- ❖ If a student has not been picked up by 5:30 pm without communication from a parent/guardian, The Sierra Vista Police may be contacted by staff. There will also be a charge of \$1.00 per minute after 5:30PM. If lateness continues to become an issue, your child will no longer be allowed in Aftercare.

General Aftercare Rules

- 1. Respect the school, other students, and all teachers/staff. Students are expected to take care of the school property.
- 2. **ZERO Tolerance** for: Bullying, Violence, and Inappropriate Language/ Behavior & Gestures
- **Aftercare is a privilege for working parents. If a student is misbehaving, the student will be removed from the aftercare program. Child must be potty trained and able to use a bathroom on his/ her own.
- 3. All toys and electronic devices are not allowed in aftercare. Berean Academy is not responsible for any lost, stolen, or damaged items if bought.
- 4. Students are allowed to bring snacks to eat during aftercare or aftercare will provide a snack.
- 5. Flex Friday Aftercare students must be here by 8:00AM. They are NOT allowed to be dropped off at 12:00PM for Aftercare. (Aftercare will not accept any child that is dropped off at 12:00PM.)
